Clark Peri a licensed Civil Engineer and Project Management Professional, earned his Bachelor of Science Degree from the University of Nevada, Reno in 1988 and went to work for Caltrans in their Division of Structures shortly thereafter. Clark's 30-year career with Caltrans includes positions in the Division of Engineering Services

as a Structures Project Engineer in Transportation Architecture and Project Coordination Engineer, and A & E Coordinator in the Division of Procurement and Contracts.

In 2003 Clark joined District 3 as a Project Manager. As a Project Manager, Clark leads project development teams to delivery of transportation and bridge projects and provides oversight for local funded projects on the State

Highway System within District 3. His current workload includes the US Highway 50 HOV and Pavement Rehabilitation Project in Sacramento, which will be completed using a Design-Build contract, and the CapCity Corridor Improvements Project in Sacramento.

SYNOPSIS

The CapCity freeway, also known as State Route 51 and Business 80 is the most congested freeway in the Sacramento region. In 2016, the freeway experienced over 2 million vehicle hours of delay at a cost of \$27.5 million to the users. The freeway has five of the top 10 bottlenecks in the region. As the region continues to grow, conditions are expected to significantly worsen. Caltrans is facilitating a collaborative effort to address congestion and improve conditions for all transportation modes in and around this route from J Street to Arden Way.

Mr. Peri will present the details of the project, give up update on the project status, and discuss some of the challenges.

First Annual Public Agency Excellence Awards Announcement.

ACEC-CA Sierra Chapter will recognize public agencies in the region for excellent performance on key issues that are important to ACEC-CA and its member firms. The process of nomination, selection, and award is described below.

Award Categories

There will be 5 award categories:

- 1. Best Practice of Qualifications Based Selection (QBS) for Engineering and Surveying Services

- 3. Best Use of Tax Payer Dollars for Infrastructure Design/Construction/Maintenance

Nomination Rules

- An agency can be nominated for multiple award categories.

Selection Process

- A 4-person committee reviews and scores the applications for all categories. The committee will consist of 2 ACEC-CA
 Sierra Chapter members and 2 members of a public agency.
- The award committee selects winners based on highest scores in each category.

Award Ceremony

- Each ACEC-CA Sierra Chapter member firms who nominated a winning agency will be given 5 minutes to present the award and explain why the public agency was selected as a winner.
- ACEC-CA Sierra Chapter member firms will have the opportunity to sponsor a table at the dinner.

To increase production capacity by 30 million gallons per day, the Orange County Water District (OCWD) is expanding their Groundwater Replenishment System (GWRS). Shannon & Wilson conducted geotechnical and hydrogeologic studies at the site to evaluate foundation support, construction dewatering, and ground improvement mitigation for a diversion structure, a pump station, and two 135-ft-diameter tanks at the northern end of Orange County Sanitation District's (OCSD) Plant 2 site. Shannon & Wilson evaluated the presence of unmapped splays of the Newport-Inglewood Fault Zone and developed mitigation measures for fault rupture.
