# November Meeting Recap - Sabrina Drago, STA

There was a great turnout for our November inperson meeting. We had the pleasure of having Sabrina Drago, the Executive Director from Sacramento Transportation Authority (STA). She talked about the creation of STA in 1988 when Measure A, the ½-cent 20-year transportation tax, passed. In addition to Measure A, STA administers the Freeway Service Patrol and the Abandoned Vehicle Abatement Program.

Ms. Drago explained that while the STA does not procure their own projects, they fund critical

projects in the area such as the Capitol Southeast Connector, the US 50 widening, I-5 managed lanes and Folsom Crossing and Richards/I -5 Interchange. They help to move a project forward or serve as a local match for state or federal funds.

Looking to the future STA put Measure B out, an additional 30-year ½ cent sales tax, for a vote in 2016. It failed by less than 1%. Sabrina had hoped to get support for a new measure this fall,

but the community support was just not there. Not to worry, there is a "citizens' initiative" that is tackling this funding. Sabrina closed by saying STA recently conducted public meetings as part of the 10-year expenditure plan review and have added bicycle and pedestrian improvements as eligible expenditures.

# **Mentoring our Future Professionals—CREATE**

When I joined the Board two years ago, I was impressed to see the many different ways the Sierra Chapter supports our local students. However, I thought we could expand our outreach with high

school students. After discussing this with the Board, a colleague of mine introduced me to the CREATE (Construction, Re-Development, Engineering, Architecture, Trades, Education) program which is run by the Construction Industry Education Foundation in partnership with the Sacramento Regional Builders Exchange. The goal of CREATE is to "educate and inspire students to pursue pathways which create the built environment." This program includes over 75 high schools all over California and over 10,000 students have participated since its inception. The program pairs mentors from the design and construction industry with high school junior and senior students to complete a semester long project that includes planning and design. I joined the program this semester as a mentor and was assigned to a class at Whitney High School in

Rocklin. Among our team of mentors, I was the only civil engineer and was joined by two architects, one HVAC contractor, and one telecommunications contractor.

Our group of six students chose to design a new sports medicine facility for their campus as their existing facility was inadequate. The project requirements included completing sketches, a floor plan, 3D renderings, engineering calculations, and architectural exhibits. We met with the students every couple of weeks and provided guidance on the planning and design process. I also gave a presentation on the many different disciplines of engineering along with a brief talk on storm water management and water quality as it related to our project. Students were also required to complete resumes and visited an active

construction site at a local high school. The field trip to the job site was a highlight and I believe all of the students enjoyed the opportunity to put on a hard hat and safety vest for the first time. The project culminated in a presentation and competition with groups from other schools where a winner was selected.

I am also pleased to report that the Sierra Chapter is supporting a new scholarship for CREATE this

semester. Scott Lillibridge awarded a \$2000 check to the scholarship winner, Stephanie Ketcham, at the CREATE awards luncheon on December 9th. Stephanie is a senior at West Campus High School and intends to pursue a degree in civil engineering as a direct result of her participation in the CREATE program. I can definitely say that I found this experience rewarding. Helping young people learn more about our profession is just one way we can give back to all of the mentors that have influenced each of our careers.



#### FOR ENGINEERING & LAND SURVEYING STUDENTS

Every year, ACEC California's Scholarship Foundation awards scholarships ranging from \$1.000 to \$8,000 each to deserving college students working toward a degree in engineering and/or land surveying. The top award recipient is nominated to apply for the ACEC National scholarship competition. For this scholarship year, we plan to give up to \$50,000 in scholarships to students!

Scholarship application packets are posted on our website and are also emailed to college Engineering Departments throughout California.

#### \*Requirements:

- 1. Be entering your junior, senior, fifth or master's degree year in the Fall of the year you are applying.
- Upper division undergraduate students must be enrolled full-time and working toward a degree in an engineering or land-surveying curriculum approved by the Accreditation Board for Engineering and Technology (ABET).
- Master's degree students must be enrolled at least half-time, and either be in an ABET-accredited Master of Science (MS) engineering program or have a Bachelor of Science (MS) degree from an ABET-accredited engineering program.
- Applicants must have a minimum grade point average of 3.2 in completed engineering and land surveying courses and a minimum overall grade point average of 3.0 on a scale of 4.0.
- Applicants must be a United States Citizen. (Only applicable for potential CA scholarship winner eligible for national scholarship.)
